

## ENERGY POLICY

Dufenco Travi e Profilati S.p.A. and its subsidiaries pursue the objectives of sustainable growth of their business and the satisfaction of all interested parties (employees, customers, institutions, citizens, etc.).

In this context, as an "energy-intensive" company:

- recognises the role of the energy element as strategic in its activities and meritorious of a specific company policy;
- is convinced that proper energy management is the most effective solution to reduce costs and at the same time climate-changing emissions, bringing economic and environmental benefits and facilitating compliance with international commitments (Emission Trading System).

Energy policy is expressed in the following management principles:

- a) fully comply with existing legislation (including any other energy requirements voluntarily subscribed by the company) and reference legislation;
- b) use products and services that minimise energy impacts;
- c) identify the activities and/or areas responsible for energy consumption, in order to identify potential actions that allow for an improvement in energy efficiency;
- d) implement and maintain an Energy Management System in all production sites, in compliance with the requirements of the UNI EN ISO 50001 and aimed at continuous improvement of its energy performance;
- e) to systematically share information on this Management System with business stakeholders (internal and external).

The Management, in collaboration with the Energy Manager, defines objectives aimed at improving the Group's energy performance and provides adequate resources for their achievement: these objectives are measurable (where applicable) and consistent with this Policy, which is the framework for their definition and review.

The achievement of these objectives involves:

- ensure compliance with all applicable energy requirements;
- continuously monitor the energy impact of each business operation, from strategic decisions to operational activities;
- to provide, where necessary, for appropriate remedial or improvement measures;
- adopt, where economically viable, the best technologies available on the market to improve energy performance, encouraging the use of Energy Efficiency Titles;
- to promote the optimal use of energy resources, with a view to saving, but maintaining unchanged the output resulting from their use (production of goods/services, comfort for employees, etc.);
- training and empowering staff on a continuous and continuous basis for responsible and efficient use of energy;


